The STAGES

“JS” or Jumping Stage

“JS” is a 1 X 7 straight-line matrix that is the entry level for all new members to the marketing plan who purchase 2 e-Books. This is a Free Entry into the Jumping Stage. It is given freely to the people that purchase the “2-Book” Offer. The purchase price for 2 e-books totals \$59.00 USD. New members will automatically get access to their own personalized World Light Web page that they can use to sell the products and refer new people to their organization. Although the same member may join multiple times, only one personalized web page will be assigned per member. All new members are placed in the first available spot in the matrix regardless of who referred them to the program. The JS is split up into 2 Phases:

Phase 1:

1 X 7 straight line with a total volume of \$413.00 USD (7 x \$59)

Once seven other members join the JS behind you, regardless of whom their referrer is, they will fill in the 7 spots allowing you to complete Phase 1.

You will earn:

Phase 2:

Phase 2:

In order to complete Phase 2, each of your seven Phase 1 downline members must each accumulate their own seven members who've followed them from the JS. As each one of those seven members completes their Phase 1, you will earn:

- 2.5% Automatic¹ Commission on the volume of each of your seven downline members paid to you as soon as each completes their Phase 1, earning you \$21.00 per member.

Phase 2:

In order to complete Phase 2, each of your seven Phase 1 downline members must each accumulate their own seven members who’ve followed them from the CS. As each one of those seven members completes their Phase 1, you will earn:

- 2.5% Automatic¹ Commission on the volume of each of your seven downline members paid to you as soon as each completes their Phase 1, earning you \$43.75 per member.
- Total earned once all seven complete their Phase 1: 7 X \$43.75 = \$306.25
- Total Automatic¹ Commission earned for Phase 1 & 2: \$393.75
- 1 BBC re-entry to the CS for each of your seven members that complete their Phase 1, totaling 7 re-entries to the CS. (worth \$840.00)

Once seven other members follow you from the CS, regardless of whom their referrer is, they will fill in the 7 spots allowing you to complete Phase 1.

You will earn:

- 5% Automatic¹ Commission of the Total Volume of \$3500.00 = \$175.00

Phase 2:

In order to complete Phase 2, each of your seven Phase 1 downline members must each accumulate their own seven members who’ve followed them from the CS. As each one of those seven members completes their Phase 1, you will earn:

- 2.5% Automatic¹ Commission on the volume of each of your seven downline members paid to you as soon as each completes their Phase 1, earning you \$87.50 per member.
- Total earned once all seven complete their Phase 1: 7 X \$87.50 = \$612.50
- Total Automatic¹ Commission earned for Phase 1 & 2: \$787.50
- 1 BBC re-entry to the CS for each of your seven members that complete their Phase 1, totaling 7 re-entries to the CS. (worth \$840.00)

Payment Schedule

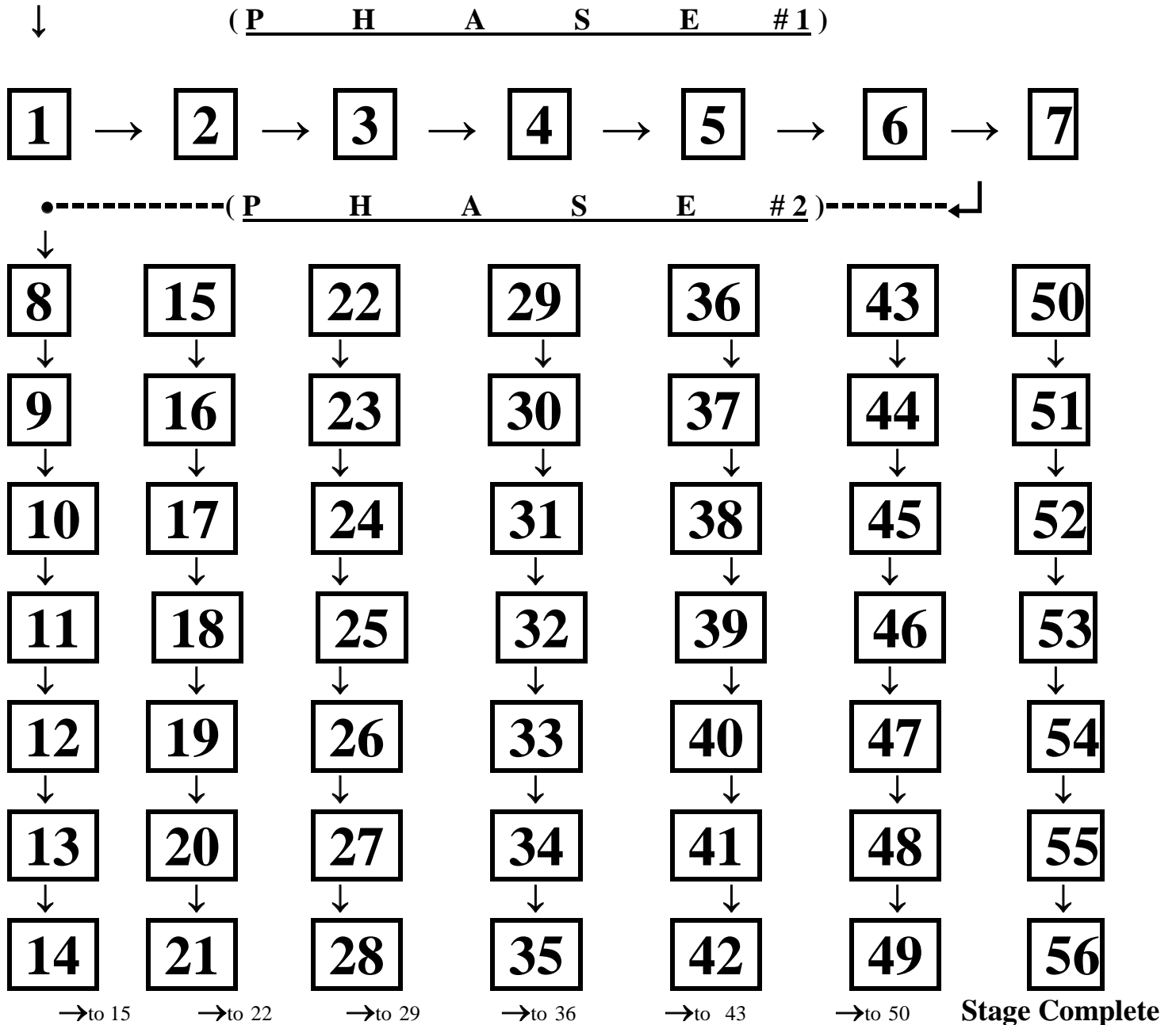
The commissions are sent out on the first of the month (around the 5th). Members earn commission every time Phase 1 or Phase 2 of any of the Main Stages are completed. Commissions are also paid when each member’s Option Entry triples. Commission is not recurring... as a new Phase is completed, additional commission is earned. Matching Bonuses accumulated throughout each calendar month will be paid at the same time as the Passive Commission. The pay will include the Passive and Matching Pay also...read on...

MODEL OF A COMPLETED CYCLE

The chart below shows a completed Cycle for the JS, CS, MS or DS Stages. The diagram begins with YOU as you are entering the JS Stage. Phase #1 is comprised of the 7 new Members that follow YOU into the JS Stage. Phase #2 begins when each of your 7 Members completes their own Phase #1 with new members following them into the JS, filling in all the spots in the Straight Line Matrix. Members flowing into the JS will be a combination of new Members, and of BBC's, allowing for a fast, uninterrupted completion of the Cycle. Notice the "straight-line" matrix pattern below:

MULTI-UP System

(This is based on the "Package" sales – "2-ebook" or "12-ebook" purchases that include free matrix entries.)

The first 2 personally referred e-book sales (of the "2-ebook" purchase) that a new member makes are actually Passed Up to the member that referred them to the program. Those 2 members become Indirect Sales for the referrer. After those first 2 members (who you passed up to your referrer), all new referrals that you personally make (Direct Sales) will Pass Up their first 2 sales to you, which gives you the matching bonuses for those new indirect downline members. Once those new downline members start referring new people, guess who gets each of their first 2 sales? YOU! ...and their first 4...and their first 8....16...32...64...!

When you come into the program, the computer is looking for your first 2 referrals and will pass them up to your qualified sponsor. (If your enroller is already qualified, then you will stay under them and they will match what you make passively – see page 8. If they are not yet qualified, then you will be passed up to their qualified sponsor for matching – either way, that doesn't affect YOUR PAY!)

Although this is hard to draw two-dimensionally, it is best explained like this...

Let's say your first two signups (after joining) are Nancy and Nathan. Nancy and Nathan are rolled up to your qualified sponsor and your sponsor is matching You, Nancy and Nathan.

You Now Qualify For Matching Bonus Pay.

Now YOU sign up Adam. YOU get Adam and the computer will roll Adam's first two up to you...

Adam signs up → Bill & Beth and both of them are sent up to you for matching pay!

Now Bill signs up → Conner & Cory and Beth signs up → Cary & Cindy AND all four of these are passed up to you for matching pay! (Then each of those four will give you two each!)

At this time you are matching Adam, Bill & Beth, Conner & Cory & Cary & Cindy 50% of their pay!

This goes to infinity! You see, the last four (Conner, Cory, Cary and Cindy) will pass you their first two sign ups EACH. That will move eight (8) new people up to you for matching pay! (Now you are matching 15 people total.)

Then the last eight that were moved up to you will send you 16 people to match pay! Then 32, then 64, and so on! Just Imagine! (Multiply all of this by the chart on page eight – the passive pay!)

When Adam first signed up Bill & Beth, that qualified Adam for matching pay – you will always match Adam, nevertheless, he will not pass up any more...just Bill & Beth. Then Bill and Beth, each, gives you two which equals four. Then those four, each, gives you two which equals eight. The eight give you 16 and the 16 give you 32 and the 32 give you 64...128...256...to infinity! The OPTION ENTRY

This Includes The Jumping Stage AND The “OPTION” Line Entry Also!

(You will get a Jumping Stage Entry and an Option Entry)

The OPTION is another separate – individual paralleling straight line matrix!

The Option Entry will “Triple” upon each three “12-ebook Package” sold that puts 3 Free Option Entries in the line. The Free Option Entry is freely given to people who purchase the “12-ebook Package” for \$347.00 USD. Let’s look at the line...

INDEPENDENT MARKETING REPRESENTATIVE AGREEMENT

I hereby apply to become an independent marketing representative (hereinafter "representative") of the World Light Corporation (hereinafter "Company") marketing program.

As an independent representative, I understand and agree that:

1. I am of legal age in the state in which I enter this agreement.
2. I shall become a Company representative upon acceptance of this application by the Company. As a representative, I shall have the right to sell the services and products offered by the Company in accordance with the Company's marketing program and statement of policy, which may be amended and changed from time to time.
3. Upon notification to representatives, the Company, at its discretion, may amend the marketing plan, product pricing, statement of policy, etc.
4. I have carefully reviewed the Company's marketing plan, rules and regulations, and policies and procedures, and acknowledge that they are incorporated as part of this agreement in their present form and as modified from time to time by the Company.
5. The term of the Company representative agreement is non time restricted.
6. **A representative shall be entitled to cancel participation in the marketing program at any time and for any reason upon notice to the Company within 30 days.** Upon notification of cancellation or termination, the sponsoring representative or the Company will repurchase inventory and mandatory sales kit materials in accordance with its policies as stated in the Company's marketing program and statement of policy.
